32. Prices

- i. Prices quoted must be firm and shall not be subject to any upward revision on any account whatsoever throughout the period of contract. Tenderer however reserves the right to review the charges payable for the Maintenance and Management of the infrastructure at any time at the request of Tenderer whichever is earlier to incorporate downward revisions as applicable and necessary.
- ii. If at any time, during the period of contract, the PIA offers identical services/products to any other Govt. Department/ Organization at prices lower than those chargeable under this contract, he shall notify the same to the Tenderer and extend such reduced prices to the Tenderer with immediate effect.
- iii. At any time during the contract (a) if it comes to the notice of GFGNL regarding reduction of price for the same or similar works; and/ or (b) the prices received in a new tender for the same or similar works are less than the prices chargeable under the contract. The prices would be determined as follows:
 - iv. The prices once fixed will remain valid during the scheduled time period except for the provisions in clause of "Price" of this RFP.
- v. GFGNL, for the extended period, if any, will determine and intimate the new price, taking into account various related aspects such as quantity, geographical location etc., and the date of its effect for the balance works to the vendor. In case the vendor does not accept the new price to be made applicable during the extended period and the date of its effect, GFGNL on behalf of DIGITAL BHARAT NIDHI(DBN), DoT shall have the right to terminate the contract without accepting any further works. This termination of the contract shall be at the risk and responsibility of the Contractor and GFGNL reserves the right to give work order for the balance works at the risk and cost of the defaulting vendor besides considering the forfeiture of its performance security.
- vi. The Contractor while applying for extension of time for works, if any, shall have to provide an undertaking as "We have not reduced the price, and/ or offered price the same or similar works to any person/organization including Department of central/state Government or any central/state PSU at a price lower than the price chargeable under the contract for scheduled time period."
- vii. In case undertaking is not applicable as above, the vendor will give the details of prices, quantity etc. to GFGNL, while applying extension of delivery period.
